The Company and Mr. Liu Quanqing entered into the Placing Agreement pursuant to which the Company had conditionally agreed to allot and issue the 108,000,000 Placing Shares to Mr. Liu Quanqing at a price of HK\$0.2091 per Placing Share on 23 December 2019. Given that one or more conditions precedent to the Completion in the Placing Agreement are not satisfied at or before 5:00 pm (Hong Kong time) on the Long Stop Date (i.e. 31 January 2020) and the Company and Mr. Liu Quanqing have not entered into any supplemental agreement to extend the Long Stop Date, the Placing Agreement was terminated automatically on 31 January 2020.
